Course Description: A study of the integration of neural, metabolic and vascular factors that compete to simultaneously regulate blood pressure and blood flow during physical exercise in health and disease. The course examines the integrative responses and mechanisms that regulate the human cardiovascular system during the physical stress of exercise and how these mechanisms are modified by age and some disease states. The neural reflexes that modify cardiovascular function for the adjustment of blood pressure and/or blood flow, and how they interact with local vascular control features, form a major component of the course. The course emphasizes an integrative physiologic approach, challenging the student to understand how several body systems interact concurrently to sustain cardiovascular homeostasis.

Kinesiology 4432: Physiology 1021 or equivalent, and Kinesiology 2230A/B. Physiology/Pharmacology 4420: Physiology 3120, 3130Y and Physiology 3140A.

#### **Recommended Text:**

Course materials, including course outline, readings and lecture notes, are available at webct.uwo.ca Past exams or exam questions are not available. Readings that parallel the lectures are assigned. The readings are in journal article or book chapter format. The weekly readings will emphasize the physiology, methodology and/or clinical aspects regarding reflex cardiovascular control. You are responsible for obtaining all course readings and most of these will be available through the OWL course site. The material in these readings will form the basis for, or supplement, the lecture presentations and their content will be considered in examinations.

#### **Learning Objectives:**

Upon completion of this course students will be able to:

- 1. **Identify and delineate** theoretical terms, concepts, and philosophies related to the cardiac, vascular and autonomic nervous system adjustments during exercise and how these (and other) systems work together in complex integrative physiology (Knowledge)
- 2. **Compare and contrast** theoretical and experimental approaches to the study of reflex cardiovascular control and how such variations affect interpretations. (Analysis)
- 3. **Synthesize** research and theoretical knowledge as it relates to the regulation of blood pressure and blood flow at rest and during exercise in various populations. (Comprehension)
- 4. **Develop** skills in critically evaluating scientific literature, and in considering various options that the body has to accomplish goals such as elevating blood pressure, or adjusting blood flow to skeletal muscle during exercise, and how such options vary from person to person. (Application)
- 5. **Further develop** abilities to *critically reflect* upon research findings, and your own learning, and relate these to the topics discussed in class. (Reflection)

#### **Required Course Material:**

#### **Course/University Policies**

# 3.3. The Exercise Pressor Response (the Metaboreflex) in health and disease.

Sensory nerve fibres from skeletal muscle signal changes in muscle metabolism that elicit a cardiovascular response.

#### Lecture 4. Central Command

The brain remains a frontier area of research in many aspects, including exercise science. How are muscle activation and cardiovascular responses coordinated during exercise? This lecture will expose students to the concept of central command, and touch on recent neuroimaging studies that examine the cortical organization for cardiovascular control during exercise.

# Lecture 5: Sympatholysis: Balancing the field between vasodilation and vasoconstriction during exercise.

This lecture will attempt to tie many aspects of this course together by addressing the following question: Just how does one justify the ideas the we need considerable vasodilation to satisfy blood flow needs to exercising muscle with the competitive need to defend blood pressure in the face of a limited cardiac output? Is muscle blood flow or blood pressure the regulated variable in exercise?

# Lecture 6: Regulation of Heart Rate and Methods Related to Research Into Exercise-Induced Bradycardia:

Time will determine whether additional lectures are given regarding:

- a) Cardiovascular control in microgravity and its analogs.
- b) Cerebral blood flow control
- c) Clean up and Review
