3. Course Description and Design

Through this introductory course the student will learn the physics and methods of how medical images are formed. By the end of the term the student will understand how images are formed for the following different imaging modalities: ultrasound, x-rays, computed tomography, nuclear medicine, positronemission tomography, and magnetic resonance imaging. To understand the tomographic imaging modalities, the student will also gain knowledge of the Fourier Transform and its applications in medical imaging. A basic understanding of the sources of noise and artifacts in the different modalities will also be attained, along with an understanding of the limits to the achievable resolution.

Antirequisite: the former Medical Biophysics 4475A/B.

Prerequisites (undergraduate students only): One of Calculus 1000A/B, Calculus 1500A/B, Numerical and Mathematical Methods 1412A/B, the former Applied Mathematics 1412A/B, the former Applied Mathematics 1413; and one of Physics 1201A/B, Physics 1401A/B, Physics 1501A/B, the former Physics 1028A/B, the former Physics 1301A/B.

Unless you have either the requisites for this course or written special permission from your Dean to enroll in it, you may be removed from this course and it will be deleted from your record. This decision may not be appealed. You will receive no adjustment to your fees in the event that you are dropped from a course for failing to have the necessary prerequisites.

4. Learning Outcomes and expectations for students who complete this course

- Understanding the foundational physics and underlying methods used to generate medical images based on ultrasound, x-rays, computed tomography, nuclear medicine methods, positron-emission tomography, and magnetic resonance imaging.
- To understand the underlying principles for tomographic imaging modalities, including how to manipulate and use the Fourier Transform and how it is used in applications in medical imaging.
- A basic understanding of the sources of noise and artifacts in the different imaging modalities discussed
- Understanding the fundamental limits for each of the imaging methods with respect to spatial and temporal resolution

Information about flexibility in assessment (applies to undergraduate students only)

- Flexibility in assessment has been applied to this course; therefore, academic consideration requests may be denied on the assessments where flexibility is included
- This course has 6 assignments with only 5 counted towards your final grade. Academic consideration will not be granted for missed assignments or assignments not submitted for grading before the graded assignments are returned to the class. Students will receive a grade of zero for any missed (or overdue as above) assignment within the required 5 assignments
- ✓ The tentative assignment deadlines can be found above in the course outline. For each assignment, students are expected to submit the assignment by the deadline listed. Should illness or extenuating circumstances arise, students are permitted to submit their assignment up to 72 hours past the deadline without a late penalty. Should students submit their assessment beyond 72 hours past the deadline, a late penalty of 10% per day will be subtracted from the assessed grade. Requests for academic consideration supported by documentation must be submitted within 48 hours of the original deadline. The instructor reserves the right to deny such academic considerations, given the deadline flexibility provided. Information about late or missed assessments:

- Late assessments without academic consideration will be subject to a late penalty 10 %/day
- An assessment cannot be submitted after it has been returned to the class; the weight will be transferred to the final grade
- One make-up midterm test will be offered on October 23, 2024 (TBD) for exams missed with academic consideration
- One make-up final exam will be offered (date to be announced after exam is scheduled) for exams missed with academic consideration
- The midterm and exam must be completed to pass the course. It these elements are missed the student will receive an INC and will complete the elements the next time course is offered].

INC (Incomplete Standing): If a student has been approved by the Academic Advising Office (in consultation with the instructor/department) to complete term work at a later date, an INC will be assigned. Students with INC will have their course load in subsequent terms reduced to allow them to complete outstanding course work. Students may request permission from Academic Advising to carry a full course load for the term the incomplete course work is scheduled.

SPC (**Special examination**): If a student has been approved by the Academic Advising Office to write a Special Examination and the final exam is the only outstanding course component, an SPC will be assigned. If the class has a makeup exam, the student is expected to write the makeup exam. If the class doesn't have a makeup exam or the student misses the makeup exam for reasons approved by the Academic Advising Office, the student will write the exam the next time the course is offered. Please note that any academic considerations granted in this course will be determined by the instructor of this course, in consultation with the academic advisors in your Faculty of Registration, in accordance with information presented in this course syllabus. Supporting documentation for academic considerations for absences due to illness should use the <u>Student Medical Certificate</u> or, where that is not possible, equivalent documentation by a health care practitioner.

Accommodation for Religious Holidays
