4. Course Description and Design

Delivery Mode: in-person (lectures to be posted in OWL Brightspace)

This course covers the fundamentals of digital image processing, including image representation, histograms, contrast enhancement, geometric operations, registration, digital filtering, and segmentation. Emphasis is placed on implementation of algorithms and on practical applications in industry, science, and medicine.

Prerequisite(s): Medical Biophysics 3503G and Medical Biophysics 3505F; Calculus 2303A/B or Calculus 2503A/B; Computer Science 2035A/B; or permission of the department.

Antirequisite(s): The former MBP 445A/B and ECE 4445 A

Unless you have either the requisites for this course or written special permission from your Dean to enroll in it, you may be removed from this course and it will be deleted from your record. This decision may not be appealed. You will receive no adjustment to your fees in the event that you are dropped from a course for failing to have the necessary prerequisites.

5. Learning Outcomes

Upon successful completion of this course, students will be able to:

1. Qualitatively describe a broad range of digital image processing techniques, including histogram-based methods, point operations, algebraic operations, geometric operations, convolution, filtering, and segmentation.
2. Understand and derive the mathematical formulation for each algorithm. Moreover, you will be able to extend the theoretical framework to adapt and optimize algorithms to new problems.
3. Program image processing algorithms in the MATLAB computation environment, which will enable you to translate mathematical algorithms into practice.

Information about flexibility in assessment

- The assignment deadlines can be found above in the course outline. For each assignment, students are expected to submit the assignment by the deadline listed. Should illness or extenuating circumstances arise, students are permitted to submit their assignment up to 48 hours past the deadline without a late penalty. Should students submit their assessment beyond 48 hours past the deadline, a late penalty of 10% per day will be subtracted from the assessed grade. Requests for academic consideration supported by documentation must be submitted within 48 hours of the original deadline. The instructor reserves the right to deny such academic considerations, given the deadline flexibility provided. If you have a long-term academic consideration or an accommodation for disability that allows greater flexibility than provided here, please reach out to your instructor at least one week prior to the posted deadline.
- Should illness or extenuating circumstances arise on the date of a test, requests for academic consideration must be submitted within 48 hours of the original deadline, and a make-up test will be organized. No supporting documentation beyond a self-attestation is required.

Information about late or missed assessments:

- Late assessments without academic consideration will be subject to a late penalty 10%/day
- An assessment cannot be submitted after it has been returned to the class; the weight will be transferred to the final grade
- One make-up test will be offered on an individual basis
- The final exam must be completed. If the exam is missed, either SPC or INC will be recorded on the student's transcripts as advised by the Academic Advising Office.

INC (Incomplete Standing): If a student has been approved by the Academic Advising Office (in consultation with the instructor/department) to complete term work at a later date, an INC will be assigned. Students with INC will have their course load in subsequent terms reduced to allow them to complete outstanding course work. Students may request permission from Academic Advising to carry a full course load for the term the incomplete course work is scheduled.

SPC (Special examination): If a student has been approved by the Academic Advising Office to write a Special Examination and the final exam is the only outstanding course component, an SPC will be assigned. If the class has a makeup exam, the student is expected to write the makeup exam. If the class doesn't have a makeup exam or the student misses the makeup exam for reasons approved by the Academic Advising Office, the student will write the exam the next time the course is offered. Outstanding SPCs will reduce the course load for the term the exam is deferred as outlined in [Types of Examinations](#) policy.
