## 4. Course Description and Design

**Delivery Mode:** in-person (lectures to be posted in OWL Brightspace)

This course covers the fundamentals of digital image processing, including image representation, histograms, contrast enhancement, geometric operations, registration, digital filtering, and segmentation. Emphasis is placed on implementation of algorithms and on practical applications in industry, science, and medicine.

Prerequisite(s): Medical Biophysics 3503G and Medical Biophysics 3505F; Calculus 2303A/B or Calculus 2503A/B; Computer Science 2035A/B; or permission of the department.

Antirequisite(s): The former MBP 445A/B and ECE 4445 A

Unless you have either the requisites for this course or written special permission from your Dean to enroll in it, you may be removed from this course and it will be deleted from your record. This decision may not be appealed. You will receive no adjustment to your fees in the event that you are dropped from a course for failing to have the necessary prerequisites.

- 3. Program image processing algorithms in the MATLAB computation environment, which will enable you to translate mathematical algorithms into practice.

Please note that any academic considerations granted in this course will be determined by the instructor of this course, in consultation with the academic advisors in your Faculty of Registration, in accordance with information presented in this course syllabus. Supporting documentation for academic considerations for absences due to illness should use the <a href="Student Medical Certificate">Student Medical Certificate</a> or, where that is not possible, equivalent documentation by a health care practitioner.
