## 4. Course Description and Design

**Delivery Mode:** blended

An introduction to the discipline of Medical Biophysics is developed through lectures on key introductory concepts and techniques used in Medical Biophysics research, real-world research seminars given by faculty members, and interactive in-class activities. Research areas include ultrasound, computed tomography, magnetic resonance imaging, molecular imaging, positron emission tomography, cancer radioligand therapy, medical physics for radiation therapy, and musculoskeletal biophysics.

Unless you have either the requisites for this course or written special permission from your Dean to enroll in it, you may be removed from this course and it will be deleted from your record. This decision may not be appealed. You will receive no adjustment to your fees in the event that you are dropped from a course for failing to have the necessary prerequisites.

## 5. Learning Outcomes

In this course, students will develop an understanding of the discipline of Medical Biophysics and the different kinds of research undertaken within Medical Biophysics. This understanding will be developed through a combination of lectures on key introductory concepts and techniques used in Medical Biophysics research.

Upon successful completion of this course, students will be able to:

- Understand the different potential career paths in science and medicine stemming from undergraduate studies in Medical Biophysics.
- Describe the steps involved in acquiring data for different types of Medical Biophysics research projects.
- Compare different Medical Biophysics research techniques and tools, and determine which techniques are best in specified situations.
- Implement simplified physical laws to solve problems in Medical Biophysics

### Information about late or missed assessments:

- Makeup tests for missed evaluations will be offered during the scheduled class on Dec 4.
- All quizzes must be completed to pass the course. If a student does not complete all quizzes, they will be given a mark of INC and will complete the missing quizzes the next time course is offered.

**INC (Incomplete Standing):** If a student has been approved by the Academic Advising Office (in consultation with the instructor/department) to complete term work at a later date, an INC will be assigned. Students with INC will have their course load in subsequent terms reduced to allow them to complete outstanding course work. Students may request permission from Academic Advising to carry a full course load for the term the incomplete course work is scheduled.

**SPC** (**Special examination**): If a student has been approved by the Academic Advising Office to write a Special Examination and the final exam is the only outstanding course component, an SPC will be assigned. ### 13. How to Be Successful in this Class

Examples of flexibility in assessment include when there are assessments not required for calculation of the final grade (e.g. 8 out of 10 quizzes) or there is flexibility in the submission timeframe (e.g. 72 hour no late penalty period).

Please note that any academic considerations granted in this course will be determined by the instructor of this course, in consultation with the academic advisors in your Faculty of Registration, in accordance with information presented in this course syllabus. Supporting documentation for academic considerations for absences due to illness should use the <a href="Student Medical Certificate">Student Medical Certificate</a> or, where that is not possible, equivalent documentation by a health care practitioner.

Marks WILL NOT be bumped to the next grade or GPA, e.g., a 79 will NOT be bumped up to an 80, an 84 WILL NOT be bumped up to an 85, etc. The mark attained is the mark you achieved, and the mark assigned; requests for mark "bumping" will be denied.
