

YEARLY CLEARANCE REQUIREMENTS FOR CLINICAL PLACEMENT

SCHULICH DENTISTRY: DENTS 1-DENTS 4

The following requirements are informed by the Schulich Dentistry Immunization Policy.

Preclinical students (Dents 2027 and 2028) must have completed their appointment with Synergy Verified and obtained a status of **PASS** by **August 14, 2024**

Clinical students (Dents 2025 and 2026) must have completed their appointment with Synergy Verified and obtained a status of **PASS** by **July 29, 2024**

DENTS 1 – ENTERING STUDENT REQUIREMENTS	
<p style="color: #4a4a9a; margin: 0;">These requirements are mandated for clinic-based learning and activity. Students are not permitted to begin any clinical experiences until proof of clearance is received for all below requirements. This checklist is for your tracking purposes only and is not part of the documentation required at your medical clearance appointment.</p>	<p>COMPLETED & DOCUMENTATION UPLOADED</p>
<p>Tuberculosis (Mantoux) – 2-Step TST (+ 1-Step TST if required) Documented proof of a 2-Step TB Skin Test (TST). If 2-Step TST was completed <i>more than 12 months ago</i>, a current 1-Step TST is also required. Note: If either TST is positive, the student will require medical follow-up with chest x-ray.</p>	
<p>Varicella A positive serologic test for the antibody, <u>or</u> Documented proof of 2 vaccinations.</p>	
<p>Measles, Mumps, Rubella (MMR) A positive serologic test for antibody, <u>or</u> Documented proof of completed vaccination series Note: Two doses of measles and mumps vaccine are required</p>	
<p>Pertussis Documented proof of vaccination. Vaccination must have occurred after 18 <u>and</u> within the past 10 years.</p>	
<p>Tetanus/Diphtheria Proof of primary series of vaccines. Proof of booster shot if primary series was completed more than 10 years ago. Note: Last booster must have been administered within the last 10 years.</p>	
<p>Polio Students are required to provide documentation of a complete series of polio vaccine.</p>	

<p>Hepatitis B- each of the below required:</p> <ol style="list-style-type: none"> 1. Proof of primary series of Hepatitis B Vaccines 2. Surface Antibody Level (Anti- HBs) -test for immunity 3. Surface Antigen Serology (HBSAg) -test for infection <p>*if immunity is not shown an additional series/booster series & antibody test required</p>	
<p>HIV A blood test (titre) is required within 6 months of the start of the school year. Documentation should include date of the test and results of the test (reactive/non-reactive). Blood tests must be renewed at the start of Year 3 (prior to entering patient clinics).</p>	
<p>HEPATITIS C A blood test (titre) is required within 6 months of the start of the school year. Documentation should include date of the test and results of the test (reactive/non-reactive). Blood tests must be renewed at the start of Year 3 (prior to entering patient clinics).</p>	
<p>INFLUENZA Annual vaccination. Documentation of annual vaccination must be uploaded to Synergy Gateway Verified by December 1. Instructions on how to do this will be sent to you by email and posted on the Learner Experience Office site in the Fall of 2024</p> <p>Note: This is NOT a current requirement for the annual clearance appointment (ERV)--students can upload this document at any time that immunizations are completed.</p>	
<p>COVID-19 Documentation of a primary series of vaccines (at least two doses) for COVID-19. A booster dose for COVID-19 is strongly recommended.</p>	
<p>NON-MEDICAL REQUIREMENTS Students with certifications expiring during the academic year must renew (before expiry) and provide updated documentation to the Synergy Verified Platform to continue to be eligible for clinical placement.</p>	COMPLETED
<p>Basic Cardiac Life Support & First Aid Certification (CPR Level HCP) If you have already obtained CPR Level HCP on your own, please note:</p> <ul style="list-style-type: none"> - First Aid Certification is valid up to 3 years - CPR Certification is valid for 1 year only. <i>Please ensure your CPR Certification does not expire before September 2025.</i> <p>The Ontario Dental Association (ODA) will offer this certification free to all ODA student members at a date in the future.</p> <p>Refresher courses/recertification courses will be available to students through years 2-4. Certification to be taken in fall 2024.</p>

<p>Police Record Check with Vulnerable Sector Screen</p> <p>A copy of a police record check with vulnerable sector screen valid for the 2024-25 school year must be supplied to Admissions Office as a condition of admission. A police check is considered expired after 1 year from the date of issue. <i>Please note that only first year students are required to submit their VSS to the Admissions Office-all other years must upload to the Synergy Verified Platform.</i></p>	

Upper Year Students:

Please note that all documentation meeting the Dents 1- Entering Student Requirements must be uploaded to your Verified account AND students must have received a notation of "PASS" on their previous year's appointment with Synergy. To determine this, students must login to their account in Synergy Gateway's Verified system and check what has been written for them under the Communications tab. If documentation is missing or follow up is required, you will see a notation. Please ensure you have all required documentation uploaded before your scheduled appointment to avoid extra charges.

The following checklists show what is required of students in each of Year 2, 3 and 4 of the DDS program (labelled DENTS-2027, DENTS-2026, DENTS-2025 respectively)

If all required documentation has not been provided, a status of "FAIL" will be assigned to your file and you will not be permitted to engage in clinical activities until you have obtained the required documentation, have booked a follow up appointment, and paid the required fee.

Criminal Record Disclosure Form A signed copy of an updated criminal record disclosure form for the 2024-25 school year must be uploaded to the Synergy Verified platform. A copy of this form is available through the Learner Experience Office website.
