4. Course Description and Design

Delivery Mode: in-person

Pharm 4360B is a half course to introduce students to the basic and advanced concepts in cancer biology and therapeutic properties of some anticancer agents. Recent advances in our understanding of the molecular and genetic basis of cancer as well as how signaling is altered in cancer cells are discussed, as well as how these alterations have led to modern targeted cancer therapies.

- Critically review relevant scientific literature.
- Design experiments to test hypotheses related to carcinogenesis.
- Communicate complex concepts related to carcinogenesis to both scientific and lay audiences

Information about late or missed assessments:

- An assessment cannot be submitted after it has been returned to the class; the weight will be transferred to the final grade

Marks WILL NOT be bumped to the next grade or GPA, e.g., a 79 will NOT be bumped up to an 80, an 84 WILL NOT be bumped up to an 85, etc. The mark attained is the mark you achieved, and the mark assigned; requests for mark "bumping" will be denied.
