4. Course Description and Design

Delivery Mode: blended; classroom and online

Prerequisite(s): Pharmacology 3620 or Physiology 3140

Course Description: This course will cover the pharmacological and pathophysiological effects of non-medicinal drug use including mechanisms of action, tolerance and addiction, long-term effects, side effects and toxicity, treatment of addictions and overdoses. Pharmacokinetics will also be examined including routes of administration, activation, deactivation, elimination, and drug-drug interactions.

Unless you have either the requisites for this course or written special permission from your Dean to enroll in it, you may be removed from this course and it will be deleted from your record. This decision may not be appealed. You will receive no adjustment to your fees in the event that you are dropped from a course for failing to have the necessary prerequisites.

Overview:

Part 1: Pharmacology of CNS drugs – general concepts

January 7 – 21

Topics to be covered: Concepts and definitions (categories of psychoactive drugs, addiction, tolerance, dependency, side effects, toxic effects, etc.); Pharmacodynamics and drug targets; Pharmacokinetics and routes of drug administration; acute and long-term tolerance; drug withdrawal; addiction; experimental methods to study tolerance and addiction.

Part 2: Effects of psychoactive drugs

January 28 – February 25

Topics to be covered: CNS depressants (ethanol, opioids, benzodiazepines, etc.); CNS stimulants; perception-altering drugs (hallucinogens, dissociatives, deliriants; cannabis).

Student Presentations

March 4 – April 1

These will focus on special topics or subclasses of psychoactive drugs. Topics will be assigned and presented in reverse-alphabetical order by surname. There will be 6 presentations per week. Students will need to upload their video presentation by the preceding Thursday for in-class online Discussion/Q&A the following Tuesday. Questions may be asked in the online Forum prior to or after class, orally during class, or via the Zoom chat function.

Each recorded presentation should be 15 minutes. Further instructions will be given in class.

Weekly lectures –the class will meet in person or via Zoom on Tuesdays at 9:30 (see the posted schedule below).

- explain the major factors underlying drug tolerance and substance use disorders
- understand how pharmacokinetic factors influence psychoactive drug effects
- know the major pharmacological targets of psychoactive drugs
- appreciate the interplay between the molecular, physiological, and psychological effects of psychoactive drugs
- understand the toxic effects of psychoactive drugs

7. Participation and Engagement

- Students are expected to participate and engage with content as much as possible
- ✓ Participation will be assessed via contributions to online class discussions and postings to associated online forums (12%), as well as timely completion of assigned peer evaluations (3%). For full participation marks, a student must contribute four *non-trivial* questions or comments each discussion day (*i.e.*, Weeks 3, 9, 10, 11, 12 and 13), either orally or in writing.
- Attendance is mandatory (5%).

General information about assessments

- ✓ Videos of assigned presentations are due to be uploaded at 5 PM EST on the Tuesday preceding the scheduled date for class discussion. There is a 48 hour grace period, after which late submissions without academic consideration will be penalized 10% per day. Presenters must answer all online forum questions regarding their videos by 11:55 pm the following Friday.
- Peer evaluations are due by 5 PM EST on the Friday after the assigned presentation
- Questions and comments on student presentations may be posted from the time the video is made available until 11:55 pm the following Thursday.
- Rubrics will be used to evaluate assessments and will be posted with the instructions
- Students are responsible for ensuring that the correct file version is uploaded; incorrect submissions including corrupt files could be subject to late penalties (see below) or a 0. If you run into technical difficulties uploading, please contact the TA or course manager as soon as possible.

Information about late or missed assessments:

- Late assessments without academic consideration will be subject to a late penalty **10%/day**.
- One make-up test will be offered for missed Midterm or Final Exam. Format may be different, at the discretion of the course manager.
- Class attendance is mandatory. One unexcused absence is permitted, and thereafter 0.5% will be deducted from the attendance mark per missed class, up to a maximum of 5%.

INC (Incomplete Standing): If a student has been approved by the Academic Advising Office (in consultation with the instructor/department) to complete term work at a later date, an INC will be assigned. Students with INC will have their course load in subsequent terms reduced to allow them to complete outstanding course work. Students may request permission from Academic Advising to carry a full course load for the term the incomplete course work is scheduled.

SPC (**Special examination**): If a student has been approved by the Academic Advising Office to write a Special Examination and the final exam is the only outstanding course component, an SPC will be assigned. If the class has a makeup exam, the student is expected to write the makeup exam. If the class doesn't have a makeup exam or the student misses the makeup exam for reasons approved by the Academic Advising Office, the student will write the exam the next time the course is offered. Outstanding SPCs will reduce the course load for the term the exam is deferred as outlined in <u>Types of Examinations</u> policy.

Examples of flexibility in assessment include when there are assessments not required for calculation of the final grade (e.g. 8 out of 10 quizzes) or there is flexibility in the submission timeframe (e.g. 72 hour no late penalty period).

Please note that any academic considerations granted in this course will be determined by the instructor of this course, in consultation with the academic advisors in your Faculty of Registration, in accordance with information presented in this course syllabus. Supporting documentation for academic considerations for absences due to illness should use the <u>Student Medical Certificate</u> or, where that is not possible, equivalent documentation by a health care practitioner.
