4. Course Description and Design

Course description: Taking a life cycle approach to the study of reproductive health across familial generations involves the investigation of the impact of factors such as diet, exercise, environmental stress, legacy chemicals, substance misuse and mental health, throughout life. This course will investigate select factors that influence female and male fertility, pregnancy, and newborn outcomes that set the trajectory for life-long and family transgenerational health and well-being. This course also investigates the influence of communicable and non-communicable disease on reproductive health and across the life course. The importance of reproductive health on quality of reproductive life will also be highlighted by addressing its impact on the UN Sustainable Development Goals.

Delivery Mode:

- One to two hours or equivalent online pre class reading and
- two hours in-person (lecture and invited speaker)

Information about flexibility in assessment

Information about late or missed assessments:

- ✓ Late assessments without academic consideration will be subject to a late penalty 20%/day
 ✓ Students unable to complete the in class group presentation will be assigned an individual essay
- An assessment cannot be submitted after it has been returned to the class and the weight will be transferred to the final exam.
- Students must have a passing grade in both the Essay and the Final examination. If these elements are missed the student will receive INC and student completes it the next time course is offered.

INC (Incomplete Standing): If a student has been approved by the Academic Advising Office (in consultation with the instructor/department) to complete term work at a later date, an INC will be assigned. Students with INC will have their course load in subsequent terms reduced to allow them to complete outstanding course work. Students may request permission from Academic Advising to carry a full course load for the term the incomplete course work is scheduled.

SPC (**Special examination**): If a student has been approved by the Academic Advising Office to write a Special Examination and the final exam is the only outstanding course component, an SPC will be assigned. If the class has a makeup exam, the student is expected to write the makeup exam. If the class doesn't have a makeup exam or the student misses the makeup exam for reasons approved by the Academic Advising Office, the student will write the exam the next time the course is offered. Please note that any academic considerations granted in this course will be determined by the instructor of this course, in consultation with the academic advisors in your Faculty of Registration, in accordance with information presented in this course syllabus. Supporting documentation for academic considerations for absences due to illness should use the <u>Student Medical Certificate</u> or, where that is not possible, equivalent documentation by a health care practitioner.
